



GENERAL SALES CONDITIONS

1. PRICE

- 1.1. Our prices are ex-works Buc, packing included.
Specific packing if any will be additionally charged.

Except for specific instructions from the customer, all orders will be shipped by courier service on « freight collect » basis.

- 1.2. NRE should be included in the related PO and will be invoiced by 3D PLUS accordingly.
- 1.3. PO are not cancellable; should any PO be cancelled after acknowledgement, customer will be charged for the total NRE amount and for any outstanding manufactured pieces.
- 1.4. 3D PLUS cannot be held responsible for any damage occurring during transportation. In case of apparent damaging to packing, customer should make written reserves to the carrier.
- 1.5. Unit prices are given for requested quantities. In case of quantity modification, 3D PLUS reserves the right to review unit prices accordingly.
- 1.6. Amount of order should not be inferior to Euros 1 000.00

2. PAYMENT CONDITIONS

- 2.1. 30 days net from date of invoice
- 2.2. As a penalty clause, and in application of legal measures, the buyer will be liable for a penalty for payment delay, 15 days after **3D Plus** has sent a formal demand for unsettled payment, calculated by application on the whole of the amount still due, with an interest rate corresponding to 1.5 time the legal interest rate.

3. DELIVERY TERMS

- 3.1. Indicated leadtime takes into account current workload as well as forecast of workload during validity of the offer. This leadtime will be confirmed on Order Acknowledgement
- 3.2. In case of partial advanced payment, 3D PLUS will start order processing upon receipt of this payment

4. CONTROL OF GOODS

All products manufactured at **3D PLUS** are controlled prior to leaving the factory.

5. RESERVE OF PROPRIETY

- 5.1. Propriety transfer is effective after full settlement of our invoices.
- 5.2. Risk transfer is effective the moment our products leave 3D PLUS premises.

6. RESPONSIBILITIES:

In case of nonconformity of 3D plus products with specifications, the customer should inform **3D PLUS** within one month after receipt of products. After that date, 3D Plus shall not be held responsible for the conformity of products to specifications.

In all cases, **3D PLUS** shall not be held responsible in any way for any damage or loss resulting from the use of the products in a larger system.

7. VALIDITY

Our offer is valid one month from issuing date, or as per special conditions mentioned on our offer. After validity date, our conditions should be reconfirmed in writing.

8. CSR COMMITMENTS
